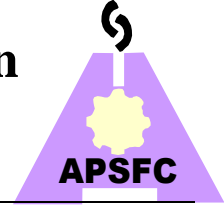

NOTICE

In response to the Sale Advertisements released on 12.01.2020 in Sakshi District Edition and The Hans India Tirupati Edition the following offer (s) have been received for purchase of land & buildings of sick units mentioned below which is / are considered reasonable for further processing of the Offer / Offers as per the sale guidelines of the Corporation. Any intending tenderer who wants to give higher offer over and above existing offer, details of which are shown hereunder may do so, on or before the expiry date of this notice i.e., by 25.02.2020 by depositing the stipulated amount of EMD as shown under col 4 of the table below, plus 15% of the displayed offer amount. The EMD and 15% of offer amount shall be deposited by means of DD/Pay order drawn in favour of “A.P. STATE FINANCIAL CORPORATION.” Fresh tenders not supported with the stipulated EMD and 15% of offer amount shall be treated as invalid offers and are liable for rejection forthwith.

In case of receipt of higher offer with the stipulated amount of EMD and 15% additional deposit for any of the offers displayed in this notice board the existing highest bidder/ tenderer shall be invited for further negotiations along with the fresh tenderers and the sale proposal shall be taken up for further processing keeping in view the highest offer that has emerged.
